The following addition and revisions to the Bylaws were proposed and discussed:

Proposed addition to the Bylaws, Section XXII - In the Event of a Dissolution of the Academy

In the unlikely event of a dissolution of the Philadelphia Academy of Surgery, all the surplus funds and financial assets under the control of the Academy will be transferred to other non-profit organizations for the benefit of surgical education. The College of Physicians of Philadelphia will appoint the Trustees of the S. D. Gross Prize Fund and Library to carry out the duties specified in the Academy's Constitution, Article VII. The College of Physicians will receive the annual report of the S. D. Gross Prize Fund by the Trustees. The College of Physicians of Philadelphia will appoint a Philadelphia area surgeon to deliver The Jonathan E. Rhoads Annual Oration. The endowments supporting The Jonathan E. Rhoads Annual Oration will be transferred to the College of Physicians. The College of Physicians of Philadelphia will appoint the Erb Lecture to speak on a topic of interest to surgeons. The endowment supporting the Erb Lecture will be transferred to the College of Physicians. All other surplus funds and financial assets under the control of the Academy will be transferred to the College of Physicians of Philadelphia to support surgical education. The artifacts of the Academy will be transferred to the Mutter Museum of the College of Physicians of Philadelphia.

Proposed revision to the Bylaws, Section XVI - Annual Dues:

from "Fellows elected in November or December shall not be subject to the annual dues for that year." to "Fellows elected after June shall not be subject to the annual dues for that year."

The Bylaw additions and revisions were accepted by unanimous vote.

The President announced that the next meeting of the Academy will be held on March 7, 2011. It will include Intra-City Grand Rounds at 5 PM, the Erb Lecture at 6 PM, and dinner following the lecture.

There being no further business, the meeting was adjourned.
